Remark 1:

11,236,860 share options were granted on 11 June 2014 (“Share Options Granted”) (of which 936,400 share options were lapsed up to 30 June 2015). Except for the lapsed share options, 3,511,530 share options out of the Share Options Granted were vested in June 2015, of which 673,040 share options have been exercised up to the end of December 2015. The vested 117,050 share options and the granted and unvested 1,346,080 share options were lapsed on 31 December 2015. The number of new shares of the Company which may be issued pursuant thereto as at close of this month is 2,721,440 shares. 5,442,850 share options out of the Share Options Granted are not vested at the date of this monthly return.

Remark 2:

10,358,990 share options were granted on 10 June 2015 (of which 2,019,120 share options were lapsed up to 31 December 2015). All the options granted are not vested at the date of this monthly return.
