

# **Nexteer Direct Material Purchase Order Clause**

# **PAYMENT STATUS:**

If you are a new supplier to Nexteer, you should have received an electronic funds transfer (EFT) payment authorization form from your buyer. This order will pay on receipt. Do not send an invoice unless specifically requested on this purchase order. This is an invoice-less system which generates payment based on receipt. Commencing November 1, 2015, Nexteer payment runs are semi-monthly on the 1<sup>st</sup> and 12<sup>th</sup> work day of each month. All payments that have reached payment maturity will be paid on the next scheduled payment run. Periodically, payment runs may change to match industry standards or to align with customer payment schedules. If this occurs, the supplier will be notified in advance of the change and this clause will be updated to reflect the new payment run schedule.

### **TAX INFORMATION:**

Purchase order numbers that have the letter "D" as the second character are not subject to any type of sales or use tax. Items on these purchase orders are used for industrial processing.
