11,236,860 share options were granted on 11 June 2014 (of which unvested 3,277,420 share options were lapsed). Up to the close of this month, 6,232,970 share options were vested, 3,398,160 share options have been exercised, and 117,050 vested share options have been lapsed. The number of new shares of the Company which may be issued pursuant thereto is 2,717,760 shares.
