Timing for Report Approval




■ Nexteer 23000000 SoC Spec and Related docs

- Utilize Available Documents on Nexteer Covisint Website
 - Nexteer 23000000 Substances of Concern and Recycled Content
 - Nexteer 23000000 Prohibited Substance Reporting Form
 - Only required if supplied part/matl contains "Prohibited" substance(s) as defined by Nexteer 23000000 specification
 - When required, must be submitted <u>as soon as possible</u>
 <u>during the design phase</u> for approval and again at PPAP in the "approved" status
 - Nexteer IMDS Reporting Instructions
 - PPAP Checklist and Instructions



SoC Requirements and Timing

- Requirements per Nexteer 23000000 SoC Specification
 - Global in scope
 - In line with Nexteer customer requirements
 - Primarily aligned with GADSL (Global Automotive Declarable Substance List)

Timing

- IMDS Reporting
 - Must be submitted, <u>and approved by Nexteer</u>, in time for submission of approval document (<u>Confirmation of Receipt with "Approved"</u> status) in PPAP package
- Nexteer 23000000 Prohibited Substance Reporting Form
 - For parts/matls with "Prohibited" substance content, Nexteer 23000000
 Prohibited Substance Reporting Form must be submitted <u>as soon as possible</u> during the design phase for approval to insure compliance.
 - Submit "approved" form at PPAP
- Either of above items may be requested earlier in design process to meet increasingly earlier customer design & material verification / review



Use of the IMDS System

- IMDS User Guide / Manual
 - Provides general IMDS system Use overview
 - On IMDS Website
- IMDS Recommendations
 - Provide acceptable reporting structure guidelines for assemblies, parts, materials, and substances
 - On IMDS Website
- "Hands-on" experience in system within company account
 - System is not "user-friendly" or intuitive
 - Takes time to learn system menus and function interaction
- Training for users
 - IMDS training docs (IMDS site or Nexteer Covisint)
 - Independent training sessions / documents (several suppliers)



IMDS Report Structure and Format

- Use IMDS site Training / Reference documents
 - > IMDS User Manual
 - General system use
 - Report generation and format
 - Report submission to customer
 - Recommendations
 - Allowed reporting formats for specific part types
 - Detailed requirements for reports, MDSs, and modules
 - Reference info for standard materials & substances
 - Additional details on report structures
- Nexteer IMDS Reporting Instructions (Covisint Portal)
- Written Training Guides, Webcasts, and Live Training Sessions
 - Available from several companies



Rejected IMDS Reports

- Submit initial report in time to allow for rejection, correction, and re-submittal
- Review "Reasons for Rejection" notes on Nexteer Confirmation of Receipt notice.
 - Unacceptable issues are noted by specific IMDS report node #s
 - Review rejection issues against IMDS User Guide and Recommendations available on IMDS site
 - If noted reasons for rejections are not understood, ask for clarification via Nexteer SoC email box: nexteer.soc.saginaw@nexteer.com
- Notify Nexteer GSM contact for further dialog / help if above methods do not resolve issue.



Nexteer SoC Waivers

- Exception to SoC requirement at the time of PPAP is granted for suppliers that
 - Only assemble Nexteer consignment or directed buy parts and,
 - Do not add any material content to the supplied part during processing or assembly at their facility
- A "Waiver" letter may be used by the Nexteer PPAP reviewer to document this exemption in the PPAP file.



SoC Conformance at PPAP

- Supplier must demonstrate SoC conformance at time of PPAP
- Item on PPAP Checklist

Required Documentation:

Inclusion of the "SoC Confirmation of Receipt" provided to supplier at time of IMDS report acceptance.

Nexteer IMDS Report Approvals

- Typical review/disposition timing of submitted IMDS reports is 1 week
- IMDS report may be rejected; most commonly for...
 - Improper report format (IMDS Recommendations)
 - Prohibited material content
 - Invalid Nexteer p/n
 - Invalid Supplier Code
 - Lack of part or material detail
 - Missing or incorrect material standards, norms, spec numbers
- The total number of times a report may need to be submitted to achieve approval will often depend on the supplier's familiarity with the IMDS system and the reporting / format requirements
- Submit initial report in time to allow for rejection, correction, and resubmittal, allowing 1 week for Nexteer final review and approval prior to PPAP
